



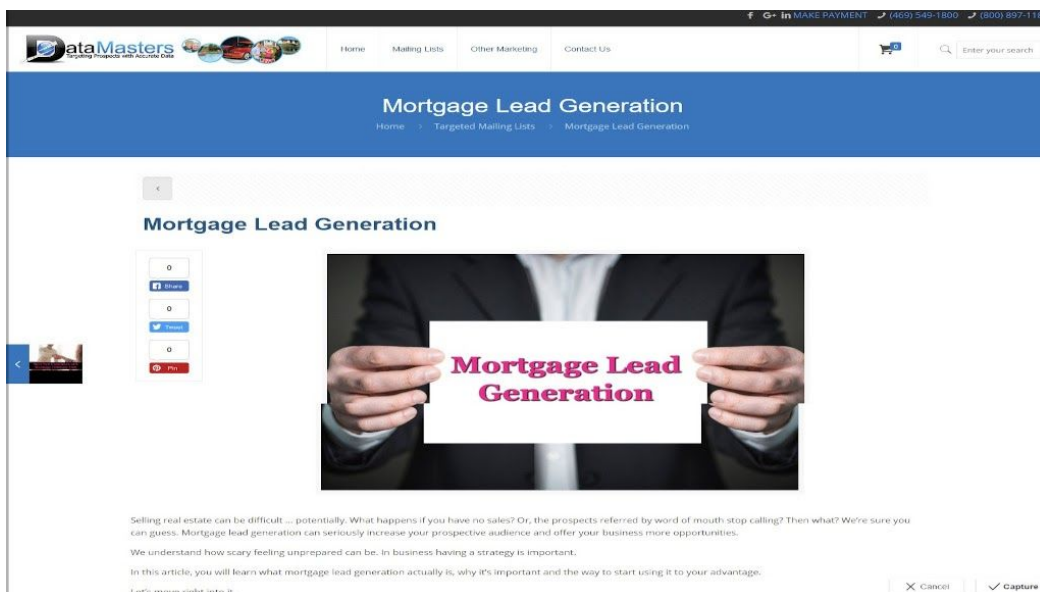

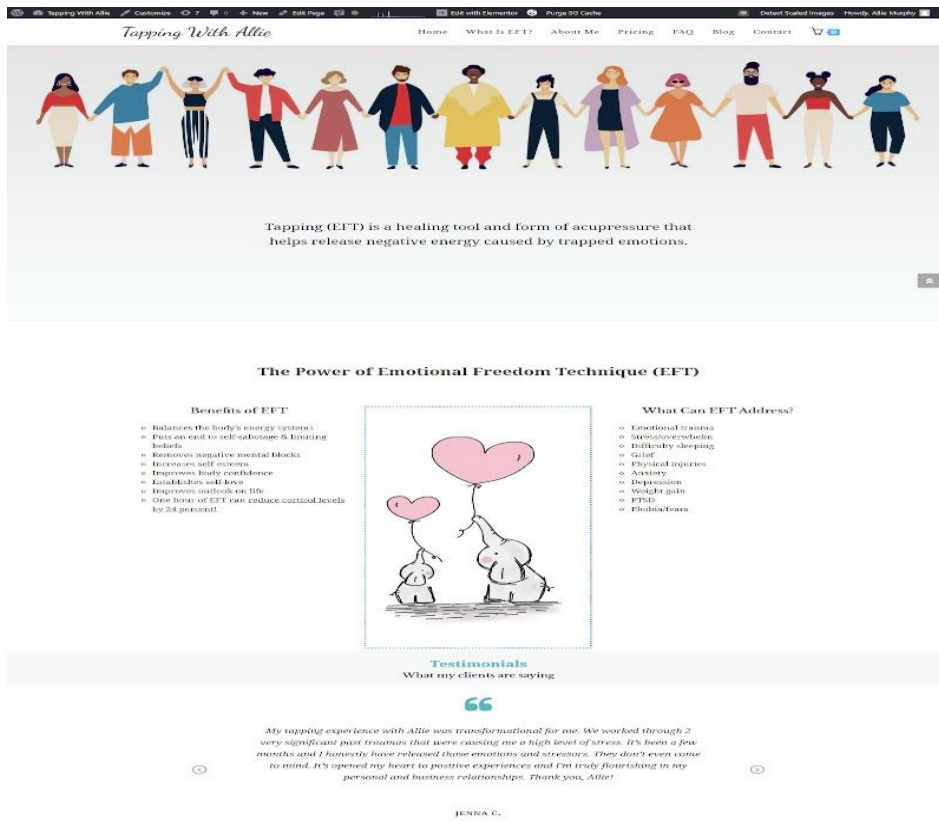

Garage Door Service

Garage doors are typically made from high-quality materials and have excellent workmanship. In order to extend the life of your door and ensure excellent operation for years to come, we suggest the following maintenance be performed twice yearly:

- Lubricate all moving parts and coil tension springs with regular grade machine oil.
- Check for loose or missing brackets. See warning concerning spring components under tension.
- Check moving parts for signs of wear. Pay close attention to end bearings, rollers, hinges and lift cables.
- Check track support system for loose joints.
- Check ease of door operation (if electrically operated, disconnect operator first). Note any binding or unusual noises.
- Check the seal of door against joints, header and floor.
- Check that all safety warning labels and tags are in place.

We recommend the above services be done by a trained professional for best results. Investing in regular maintenance can extend the life of your garage door, saving you time and money in the end.

How do I clean my garage doors?


Use a mild detergent to wash your door, do not use abrasive cleaners. Check for scratches that can be reasonably repaired. If bare metal is exposed, treat with zinc-based primer. Avoid excessive touch-up, and applied painting will not match original factory finish.
